## HYDRUS LIMITED WARRANTY

Kinetico Incorporated warrants its Hydrus<sup>®</sup> Line of products to be free from defects in material and workmanship according to the following terms and conditions:

#### What is Covered?

Any faulty parts will be replaced at no extra charge for the part if it fails within the following time periods originating from the date of purchase of your system:

- Three years for Hydrus Smart Start Control Systems including: base and elite controller, solenoid valve, chlorination probe and pressure switch.
- Three years for Simplex Softening Systems including: tanks, media and distribution system, when purchased as a complete system from Kinetico.
- Four years for Multi-tank Softening Systems including: tanks, media and distribution system, when purchased as a complete system from Kinetico.
- Five years for Hydrus valves and all Hydrus filter valves, Hydrus installation components including: plumbing adapters, backwash flow controls and brine injectors.

#### **Vended Products**

Other Kinetico products, components and accessories that are not specifically mentioned elsewhere in this warranty [including but not limited to storage tanks, valves, pumps, filter housings and electrical controls] and/or not manufactured but distributed by Kinetico through authorized dealers, are covered for a period of one year from receipt.

Warranty does not include freight or labor charges.

# Extension of Warranty to a Subsequent Installation

The ORIGINAL OWNER may move the system to another location. The influent water quality at the subsequent location MUST, however, be within your system's operating specifications. Please contact a local authorized Kinetico dealer prior to installation at another location.

### **Limits on this Warranty**

Your system must be sold to you by an authorized Kinetico dealer in order to receive coverage under this warranty.

The design and performance of your Kinetico system is related to the chemistry of the water being treated; therefore, this warranty is limited to the equipment manufactured or distributed by Kinetico.

Periodic replacement of filter cartridges and certain filter media (such as carbon and Macrolite ™) is part of the normal

maintenance required by your system. These replacements and media loss due to natural attrition are not covered.

This warranty does not include damage to your system due to:

- Abuse, misuse or neglect
- Excessive pressure (over 125 psi)
- Excessive water temperature (over 120° F)
- Freezing, alterations or misapplication
- · A change in the influent water characteristics
- Power surges
- Oxidizer content > 2 mg/L (oxidizers such as but not limited to chlorine, chloramines and peroxide)

Your equipment must be installed and operated in accordance with Kinetico's recommendations and applicable state and local codes for warranty to apply.

### **Registration and Service**

To place your system under warranty, the owner's registration card must be completed and one copy returned to Kinetico Incorporated, P.O. Box 193, Newbury, Ohio 44065, within 30 days of the installation date. For service under this warranty, you should contact the dealer or Kinetico. Retain your copy of the owner's registration card along with this warranty for reference if service is necessary.

#### No Other Warranties

THERE IS NO OTHER EXPRESS WARRANTY. IMPLIED WARRANTIES, INCLDUING ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, ARE LIMITED TO THE DURATION OF THIS WRITTEN WARRANTY AND ARE EXCLUDED TO THE EXTENT PERMITTED BY LAW. THERE ARE NO OTHER WARRANTIES OTHER THAN THOSE CONTAINED HEREIN. IN NO EVENT SHALL KINETICO BE LIABLE FOR INDIRECT, SPECIAL OR CONSEQUENTIAL DAMAGES IN CONNECTION WITH THE USE OR THE LOSS OF USE OF THIS SYSTEM.
